Pennsylvania Food Merchants Association hosts annual fall conference

CAMP HILL (October 15, 2019) – The Pennsylvania Food Merchants Association (PFMA) recently hosted its 4th- annual Fall Legislative Conference at the Radisson Hotel Harrisburg in Camp Hill.

The event was punctuated by a special guest keynote speaker, U.S. Senator Bob Casey, who spoke during cocktail hour about challenges to cuts to the federal Supplemental Nutrition Assistance Program (SNAP) and the problem of food insecurity in America.

The conference, held Oct. 7-8, included federal and state legislative panels, which discussed issues facing the food and beverage industry, the business community as a whole, and other topics of interest to attendees. Educational sessions included an update from state Gaming Control Board Chief Counsel R. Douglas Sherman on rollout of video gaming terminals (VGT) and a cyber-secutity presentation from Federated Insurance's Patrick Donahue.
